Tom Kohl (Washington State Department of Transportation) has been elected Chapter executive vice president, and will be taking an active role in numerous SWS-PNW programs.

Lastly, I have been dealt a pair of large shoes to fill, as Colin MacLaren (Interfluve) moves from Chapter president into the immediate past president role and I assume the duties of president. I wish a hearty welcome to the new board, and look forward to working together to maintain a strong, productive Chapter.

Since election season, the board and numerous volunteers have been busy preparing for the Chapter's biannual meeting. "From a Watershed Perspective: Integrating Science into Policy" will take place October 6-8, 2015 at the Red Lion Hotel and Conference Center in sunny, Olympia, Washington. A call for organized symposia and panel discussions and a call for contributed abstracts will circulate in early 2015.

We are pleased to announce that Dr. Joy Zedler, Professor of Botany at the University of Wisconsin, and recently-elected Fellow of the Society of Wetland Scientists (2013), will serve as our keynote speaker. In addition to the usual

great talks, posters and field trips, the Chapter will also sponsor numerous student scholarships for undergraduate and graduate students attending school or working in the Pacific Northwest.

Information on the 2015 SWS-PNW meeting will be updated regularly on the Pacific Northwest Chapter's website, the Chapter's newsletter, Ooze News, and through updates in upcoming issues of WSP. I also encourage you all to use the hashtag #SWSPNW on Twitter as we promote conference events via social media.

In addition to chapter business, the public comment period for Washington State's Wetland Program Plan recently closed in late 2014. The new plan spans a sixyear period, and sets priorities for the future of wetland management across Washington State.

Jim was surprised as recipient of the award at his home in Sedro-Woolley, WA by Aqua-Terr Systems, Inc. staff (Karla Van Leaven (and her fiancé, Anthony Gallina) and Janet Cray (and her unable to attend, but there in spirit husband, Garth) and his wife (Abbe). During a slideshow of a recent trip to Africa, our Chapter President Colin called in to announce the award at which point in time he was presented with an acceptance letter and a piece of artwork by Al Currier, a local artist to the Skagit Valley and a beloved friend of Jim's.

2014 Updates to the WA Wetland Rating Systems

Clarification: Effective Date of the 2014 Updates to the Wetland Rating Systems

On June 30, 2014, Ecology published the updates to the 2014 wetland rating systems for eastern and western Washington. At that time, we stated that the 2014 rating systems were effective upon publication. Therefore, local governments whose Critical Areas Ordinance (CAO) required the use of the most recent version of the rating system(s) would in effect have been requiring use of the 2014 updates immediately. We have since learned that this approach has caused difficulties for many local governments, because some jurisdictions need to update their code language on wetland buffers in order to incorporate the updated habitat scores associated with the 2014 rating systems. In addition, we discovered that several corrections to the 2014 rating systems are necessary.

As a result, the effective date of the 2014 rating systems was changed to January 1, 2015.

The corrected rating systems were more recently posted in early November (with a new published date and publication numbers). Users now have a chance to get familiar with the final updates and to attend trainings. Local governments must now determine how the updates may affect parts of their CAO. To help with this, we have posted on our web page conversion tables for point scores to assist local governments who are evaluating what changes be necessary for their CAOs. See: http://www.ecy.wa.gov/programs/sea/wetlands/rating systems/2014updates.html#tables.

The January 1, 2015, effective date means that if you rate a wetland on or after that date, you will be required to use the 2014 updates for projects needing Ecology authorization. An applicant applying for a local permit

will need to consult with that specific local government if its CAO requires the use of the rating system. If a CAO contains the language "2004 rating system or as revised," it is likely that an applicant will need to use the 2014 updates as of January 1, 2015, to address local government requirements.

Some local jurisdictions may have language in their CAO that requires the use of the 2004 rating systems regardless of whether updates exist. The 2004 versions will, therefore, also remain available on the rating systems web page at: http://www.ecy.wa.gov/programs/sea/wetlands/ratingsystems/index.html.
