Happy New Year and welcome 2019!

The New Year promises to be a very busy one for wetland scientists. The Society of Wetland Scientists is joining other aquatic science societies opposing the EPA and Corps of Engineers proposed revisions to the Waters of the U.S. (WOTUS) definition. Please read more about the proposed changes here, (<a href="https://www.epa.gov/wotus-rule">https://www.epa.gov/wotus-rule</a>), a link from the SWS website. SWS members who would like to comment on this Rule have 60 days from the time the rule is published in the Federal Register.

An update posted on Jan 7<sup>th</sup> on the EPA website states that due to the government shutdown, the EPA and Corps of Engineers (Dept. of the Army) will postpone the planned January 23<sup>rd</sup> public hearing on the proposed new WOTUS definition as well as the publication in the Federal Register. So, you have more time to prepare! Please consider submitting your own comment or as a group on this extremely important change in the rule governing WOTUS. Other items to look forward to in 2019, May is American Wetlands Month! The PNW Chapter would like to offer an activity for our SWS PNW Chapter members this May. See article below and stay tuned to find out what we will be doing, when and where!

# Recapping Restoration 2018: Restoring Resilient Communities in Changing Landscapes

Last October the Society of Wetland Scientists Pacific Northwest and the Society for Ecological Restoration Northwest held their joint meeting in Spokane, Washington. "Restoring Resilient Communities in Changing Landscapes" was jointly organized by both societies and brought together hundreds of talks and posters, a pub talk, and four invited plenary talks all united around the theme of building resilience in ecosystems and human communities during an era of unprecedented change.

The conference's events began with field trips and workshops led by many SERNW and SWS-PNW members. Attendees spoke highly of the function-based performance standards workshop organized by Washington State Department of Ecology Staff, Diane Hennessey and Teri Granger. Longtime SWS-PNW member and former chapter president, Scott Luchessa (Seattle City Light), and Ray Entz (Kalispel Tribe) led a trip to a City of Seattle restoration site associated with the Boundary Hydropower project. A few other field trips included a review of revegetation efforts over decades at the

Spokane landfill, led by SWS-PNW executive vice president Josh Wozniak (Parametrix) and City of Spokane landfill manager Scott Winsor, and a visit to an extensive wetland restoration project on the Silver Bow River in Idaho, led by Karen Cathey (USFWS). SWS-PNW is extremely grateful to all of the individuals who planned or led field trips and workshops, worked on logistics, or shared access to their field sites.

While the pre-conference trips and workshops were going full swing, Yvonne Vallette (EPA) and Bill Kirchner (USFWS) held down the registration fort with an army of other volunteers from SWS and SER and local colleges and universities. Thanks to everyone who volunteered at registration, as a moderator, or in any capacity small or large. Without so many committed volunteers and generous sponsors these meetings wouldn't be economical for our members.

Tuesday through Thursday were a whirlwind of talks, including plenaries Washington State Public Lands Commissioner Hilary Franz, National Geographic Explorer Erin Pettit, Author Jack Nisbet, USFS Fish Biologist extraordinaire Dan Isaak, and Ben Goldfarb

who delivered the Wednesday Night Pub Talk. Organized sessions on everything from wildfire and sagebrush to wetland restoration and using beaver in stream restoration (and much more) kept over 200 attendees occupied and engaged for the full three days.

SWS-PNW is extremely grateful for the work that our organizing committee, partner organization (SERNW), conference volunteers, and speakers put into making the meeting a success. # Celebrate American Wetlands Month with the PNW Chapter

### USDA's Update on Wetland Determination Guidance

On December 7, 2018, The U.S. Department of Agriculture (USDA) has issued an interim rule for the Highly Erodible Land and Wetland Conservation Compliance provisions of the Food Security Act of 1985. The interim rule clarifies the USDA's process for delineation, determination, and certification of wetlands on subject lands to determine ineligibility of certain USDA program benefits for production of an agricultural commodity on a converted wetland.

The interim rule does not change the definition of a wetland for USDA program participation purposes but rather provides greater clarity and uniformity in how NRCS makes determinations nationwide by codifying many of the technical updates into regulations. Specifically, updates to the provisions include:

- Identifying that determinations will rely on precipitation data from 1971-2000. Though data and average rainfall have varied over time, using this specific dataset makes determinations more predictable.
- Clarifying the certification status of previously completed wetland determinations, including those completed 1990-1996.
- Adding definitions for playas, potholes and pocosins. These terms are found in current policy, but they are added to the regulation for transparency.
- Clarifying that determinations do not have to cover the entire farm tract, but only the area of the farm on which a producer is planning to make changes.

- Establishing that NRCS can now assess offsite, impacts on neighboring wetlands when producers request minimal effects exemptions. For those neighboring wetlands, NRCS can now do the evaluations off-site using aerial photography and other resources.
- Incorporating criteria to better reflect on-field observations of hydrology, rather than basing determinations strictly on a set number of days.

### **WOTUS Proposed Revision**

The EPA and Army Corps of Engineers have proposed a revision to the Waters of the U.S. (WOTUS) definition, to clarify federal authority under the Clean Water Act. The public comment period is open until February 26, 2019 (60 days after its December 28, 2018 publication in the Federal Register). SWS members are encouraged to learn more about the proposed revision and consider submitting a public comment.
